

General National Congress
Resolution No. (39) of 2013 AD
on forming a committee and specifying its duties

The General National Congress,

Upon review of:

- The interim Constitutional Declaration issued on 03 August 2011 AD and amendments thereto;
- The by-laws of the General National Congress;
- The conclusions of the General National Congress in its ordinary session held on Sunday, 11 Jumada al-Akhera 1434 AH, corresponding to 21 April 2013 AD;

issued the following Resolution:

Article (1)

Article (2)

The committee shall study and assess the proposal on sending Libyan youth submitted by members of the Congress in consultation with the competent bodies.

Article (3)

The committee shall complete its work and submit a detailed report to the General National Congress stating its full conclusions on the proposals in this regard, within thirty days at most from the date this Resolution is issued.

Article (4)

The committee shall have the right to seek the assistance of anyone it deems necessary.

Article (5)

This Resolution shall enter into force on the date of its issue and shall be implemented by all concerned parties.
